NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 23rd day of September, 2015 by and between

GRANTEE

A. JAMES LYDAY, JR. and KATHARINE H. LYDAY, Trustees, or their successors in trust, under the JAMES AND KATHARINE LYDAY LIVING TRUST, dated June 12, 2015 and any amendments thereto, residing at 160 Deerlake Road, Brevard, NC 28805.

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH, that the Grantor, for ten dollars (\$10.00) and other valuable consideration paid by the grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in Transylvania County, North Carolina and more particularly described as follows:
