

#### ROAD AGREEMENT FOR CANTRELL MOUNTAIN

This agreement is made as of June 1, 2009 between and for the benefit of the parties whose signature pages are affixed to this Agreement.

#### **BACKGROUND:**

- A. The parties are owners of tracts on and in the vicinity of Cantrell Mountain, all with access to Highway 276 over Cantrell Mountain Road in Transylvania County, North Carolina. Their properties are served by Cantrell Mountain Road, Still Woods Lane, Sunny Acre Lane, Bluebird Trail, Wild Rose Lane, Cattle Drive and Miller Drive (the Roads), which run through, along, or to their respective properties. The Deed references for the properties are set forth on each signature page.
- B. The Roads are the only source of access to the parcels of the owners, and have provided access since the properties were developed into lots over twenty years ago and, for some parcels, since they were farmed by the Holden family over one hundred years ago. Portions of Cantrell Mountain Road have been referred to in old Deeds as Holden Road and Pressley Road.
- C. The Roads have been maintained for several years by the Cantrell Mountain Road Association, an unincorporated association (the Association). Most owners have contributed as needed to the Association, but membership has been informal and uncertain.
- D. The owners in Whiskey Creek along Still Branch Road have their own arrangements for road maintenance, and are not parties to this Agreement.
- E. Many of the parties are governed by the road maintenance provisions in the Covenants for Whiskey Creek, recorded in Deed Book 290, Page 154. A Road Agreement with Still Woods (Document Book 358, Page 174) requires owners in Still Woods to pay assessments to the Association. Owners with no deeded requirement to contribute to the maintenance costs are nevertheless required to do so by North Carolina law.

F. Despite many years of harmonious joint use of the Roads, many of the deeds of the parties do not specify a width for the right of way. Some deeds make no reference at all to a right of way, and many do not provide for maintenance or improvement of the Roads. Accordingly, the parties wish to document their agreement with respect to those matters.

#### AGREEMENT:

It is agreed as follows:

- 1. All parties grant and convey to all other parties to this Agreement a non-exclusive right of way for access to their respective parcels over the Roads. The right of way shall be generally considered to be 30 feet in width, with fifteen feet on each side of the current centerline of the Roads, except that Cantrell Mountain Road is a 60' right of way from Highway 276 to Still Woods, and both Cantrell Mountain Road and Still Woods Lane are 45' rights of way along and through Still Woods. Many surveys and recorded plats already show the locations for the Roads, but any party may (at the party's expense) cause a survey to be made and recorded of the centerline of any of the Roads. None of the Roads may be relocated without the written consent of the Association and the owners of properties adjoining that section of the Road.
- 2. Each party shall have an obligation to pay a prorata share of the cost of maintaining the Roads. Owners with multiple parcels shall pay a single assessment. The same amount shall be due from each Owner, whether the property is improved or unimproved, and there shall be no premium charged to Owners in Still Woods. In recognition of the wear on roads during construction, Owners shall pay a one time construction damage assessment of \$1,000 in the year a residence is built on a parcel, together with the cost of any repairs directly attributed to the construction.
- 3. Individual owners and groups of owners may assist with maintenance by cleaning culverts, trimming brush, clearing downed trees, and repairing minor damage to the Roads. Any party may provide such maintenance or minor improvements as considered appropriate at the party's own expense. However, no asphalt or other paved hard surface may be added to a Road without the consent of at least 80% of the owners abutting that Road.
- 4. All of the Roads may be used not only for access, but also as a right of way for the installation of utilities such as power lines, cable television, gas or telephone lines.
- 5. All owners shall be members of the Association, and shall have an equal vote in electing its Board of Directors. Co-owners (such as husband and wife) shall have a single vote and pay a single assessment. Bylaws shall be adopted at the first organizational meeting of the Association. Except as otherwise provided in this Agreement, the Association shall

have all powers and duties of a property owners association under Chapter 47F of the North Carolina Statutes. The Association shall have the power, but not the obligation, to purchase liability insurance.

- 6. Except for the Roads expressly provided for in this Agreement, other roads and driveways (now in existence or constructed later) shall be maintained by the owners of those properties and not by the Association. Roads may be extended to additional parcels or later included in the Association only with the approval of the Association, and subject to such conditions as may be imposed by the Association.
- 7. The initial annual assessment shall be \$200 per Owner. The parties understand and acknowledge that amount is budgeted to be slightly more than the historical annual cost of road maintenance, but hope to build a reserve for future work and to reduce the size of a special assessment when needed for major repairs. Any proposed change in the assessment amount shall be subject to ratification and approval of the Owners.
  - 8. This Agreement shall be binding on the heirs and successors of the parties.
