EXHIBIT "A" TO A DEED FROM TAYLOR TO CARROLL

Being all of Lot 1 containing 1.762 acres, more or less, as shown on a plat entitled "Property of Jack F. & Joan Parsons," prepared by Clarence A. Jenkins, R.L.S., recorded in Plat 7, Slide 101, Records of Plats for Transylvania County in the office of the Register of Deeds for Transylvania County.

This conveyance is made subject to all easements and other matters shown on the recorded plat hereinabove referred to, to the restrictive covenants recorded in Book 411, page 84, Records of Deeds for Transylvania County, and to the obligation to pay a prorata share of the costs of maintaining the 30-foot wide road right-to-way to Skyland Drive which is shown on the recorded plat hereinabove referred to.

There is also conveyed hereby and herewith a right-of-way for road and utility purposes over Skyland Drive and Fernwood Drive to Williamson Creek Road subject to the obligation to pay a prorata share of the cost of maintaining Fernwood Drive and that portion of Skyland Drive which runs in a northerly direction from the intersection of Skyland Drive and the 30 foot wide right-of-way hereinabove referred to to Fernwood Drive.

Being all of the same land described in a deed from Jack F. Parsons, et al, to William O. Taylor, Jr., and wife, Charlene F. Taylor, dated April 21, 1997, and recorded in Book 415, page 7, Records of Deeds for Transylvania County.
