THIS AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR EAGLE LAKE (the "Amendment"), is made and entered into this the 14th day of June, 2019 by and between the Eagle Lake Property Owners' Association, Inc., a North Carolina non-profit corporation (the "Association"), and the undersigned persons (the "Owners"), representing greater than seventy-five percent (75%) of the votes allocated within the Eagle Lake Subdivision located in Transylvania County, North Carolina, as the same is more particularly described herein (the "Subdivision"), to be binding upon all present and future owners of Lots within the Subdivision; the Association and Owners being sometimes hereinafter referred to collectively as the "Parties" and singularly as a "Party".

WITNESSETH:

WHEREAS, the Subdivision is subject to and governed by that certain Declaration of Covenants, Conditions, Restrictions and Easements recorded in Book 325, at Page 61 of the Transylvania County Registry, as the same was subsequently amended and restated in that certain Declaration recorded in Book 273, at Page 481 of said registry, and as the same has been further amended and supplemented (collectively the "Declaration"); and,

WHEREAS, as more specifically set forth in Section 14.4 of the Declaration, the Declaration provides that following the termination of the Class B membership the Declaration may be amended by an instrument signed by Owners representing seventy five percent of all votes of the Association; and,

WHEREAS, the developer of the Subdivision, Eagle Lake of North Carolina, Inc., a Florida corporation, terminated its Special Declarant Rights as contemplated in the Declaration, R&S 2024951 1

including, without limitation, termination of its Class B voting rights and its right to unilaterally amend the Declaration, in accordance with that certain Termination of Special Declarant Rights recorded in Book 845, at Page 139 of the Registry; and,

WHEREAS, the Parties desire to modify and amend the Declaration to provide for future amendment of the Declaration by either written instrument or affirmative vote of the Owners; and,

WHEREAS, it is the intent of the Parties that this Amendment be adopted pursuant to the Declaration and Section 2-117 of Chapter 47F of the North Carolina General Statutes, such chapter being commonly referred to as the North Carolina Planned Community Act (the "Act");

NOW, THEREFORE, for and in consideration of the premises, the mutual covenants and conditions contained herein, and for the mutual advantage and benefit to all the present and future owners of Lots and properties within the Subdivision, the Declaration is hereby amended as follows:

- 1. **Amendment**. Paragraph 14.4 of the Declaration is hereby deleted in its entirety, and in lieu thereof the following is inserted:
 - 14.4 <u>Amendment</u>. This Declaration may be modified or amended in whole or part by the affirmative vote, or execution of a written instrument, by Lot Owners to which at least seventy-five percent (75%) of the votes in the Association are allocated.
