Attachment to Articles of Incorporation RIDGE HAVEN PROPERTY OWNERS ASSOCIATION, INC.

8. Provisions regarding the distribution of the corporation's assets upon its dissolution.

The corporation is a nonprofit corporation as defined by §55A-1-40(17) of the General Statutes of North Carolina, and, as required by §47F-3-101 of the General Statutes, is incorporated for the purpose of managing the planned community known as RIDGE HAVEN and carrying out the management duties imposed upon it by the Declaration of Restrictive and Protective Covenants for RIDGE HAVEN and the North Carolina Planned Community Act. No income is distributable to its members, directors or officers, except as permitted in Article 13 of Chapter 55A of the General Statutes. No part of the net earnings of the corporation shall inure to the benefit of any member, director or officer of the corporation; and upon dissolution of the corporation, the assets shall, after all of its liabilities and obligations have been discharged or adequate provisions made therefor, be distributed in a manner authorized and permitted by Article 13 of Chapter 55A of the General Statutes.

9. Other provisions which the corporation elects to include.

Indemnification

To the fullest extent permitted by the North Carolina Nonprofit Corporation Act as it exists or may hereafter be amended, no person who is serving or who has served as a director of the corporation shall be personally liable for monetary damages for breach of any duty as a director. No amendment or repeal of this article, nor the adoption of any other amendment to these Articles of Incorporation inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.
