This conveyance is made subject to the restrictive and protective covenants imposed on certain lots in Highland Forest Subdivision, which said restrictions are recorded in Deed Book 324, Page 531, Transylvania County Register of Deeds.

Together with a right-of-way for travel of all kinds, on foot and with all types of vehicles, in common with all others entitled to the use thereof, over and along those certain roads which run through Highland Forest Subdivision and lead to the public road, with the right of ingress, egress and regress over and along the same.

Together with a right-of-way for electrical power lines, telephone lines, water and sewer lines over and across the property of the developer to connect with such utilities, said right-of-way to be located within the road right-of-way, with the right of ingress, egress and regress over and along the same for the purpose of installing, maintaining and repairing said utilities.
